Completion of the Children's Ministry Track program does not qualify a person for any type of ministry credential with the Assemblies of God, nor does it fulfill the complete educational requirements for any level of credential the student may decide to pursue.

Any student who decides to pursue ministerial credentials at some point would be required to take additional courses to complete the educational requirements for any credential level. Completion of the ARSOM study material for any level of credential does not automatically guarantee a student will be granted a credential. Credentialing is a separate process.
